YORK V. YALE: One Makes a Monopoly, Two Makes a Market

The Ph.D. program in law at York University's Osgoode Hall Law School now has some serious competition, what with the Yale Law School getting into this line of business. Reasonable minds might differ about which program is better, but not about which price is better. In the York program students pay about \$6,000 per year, which sounds like a bargain until it's compared to Yale's program, in which students are paid about \$27,000 per year.
