

THE ROBERTS(DALE) COURT

HERE IS A SENSE OF "continuity with change" after one has calculated the geographic centers of the United States Supreme Court, on and off and with tongue in cheek, for many years. Even a radical switch of a Sacramento jurist for an Eastern seaboarder translates into a shift of only one-ninth of the continent, a few hundred miles of the American expanse. Yet the distance — in all senses — between Justices looms large in our national discourse.

It is cold comfort to any partisan that the exchange of Justices Antonin Scalia and now Anthony Kennedy for Justices Neil Gorsuch and Brett Kavanaugh produces the same appointment center as a counterfactual exchange for Judge Merrick Garland and Justice Gorsuch. Such is the dominance of the Court of Appeals for the Acela Circuit in recent nominations. ⁴

In contrast to the emotions expressed during his confirmation process, there is little drama in assessing the regional roots of Justice Kavanaugh. A child of Washington and Bethesda, and a well-known graduate of Georgetown Preparatory School, he has been resident throughout his career in the vicinity of the nation's capital (lat. 38° 51', long. 77° 3'), where he served as a judge on the Court of Appeals for the District of Columbia Circuit. ⁵

Substituting Washington for Sacramento unquestionably brings the appointment center from Columbus, Ohio, back into the thirteen original colonies for the first time in decades. The appointment center now resides squarely in the heart of Pennsylvania (lat. 40° 9', long. 78° 10').

One first notes that the center lies among several State Game Lands preserves. This is hunting country. Were all nine Justices suddenly deposited at their new center (always my mental image), they would be well advised to don Blaze Orange vests (or jabots) lest they be mistaken for a covey of Grey-Crested Muttering Sable Grouse.

One then notes that the center does not fall directly within the confines of any city or town. Any of several Pennsylvania hamlets could be selected. Authorial discretion, not unlike judicial discretion, is required to decide what to call the new home.

As a counterpoint to the comparison of judging to an umpire's calling balls and strikes, ⁷ geography furnishes a novel frame of reference. We must

label the center so that it takes its place in an archipelago of analogies, just as lawyers seek to fit a case in an archipelago of precedents.

Each island in an archipelago has a collection of traits that are both similar and dissimilar to those of the island at hand. G.E.P. Howard, a celebrated Wall Street lawyer at my firm, urged his associates to find for him a "green elevator case" — a precedent that was on all fours with his pending litigation, down to the color of the vestibule. But by the time one gets to the U.S. Supreme Court, green elevator cases are rare.

What, then, should we name the new center, from among all the candidates? Animal ethicists might be uncomfortable with Wells Tannery; it might have been an offal place. Coaldale plays to one of President Trump's core constituencies, while Defiance describes his fervent opposition. Six Mile Run conveys something of the modern nomination and confirmation process. And Hopewell is perhaps the attitude of most of us.⁹

In the end I land on Robertsdale, Pennsylvania, as this iteration of Justices is widely considered to usher in the Roberts Court. The name suits the center of an institution in which the Chief Justice is himself heard as a mediating voice. ¹⁰ May all Americans come together in seeing, metaphorically and geographically, where this Court goes.
