In the headnote to "The Charles River Bridge Case, Part II" (vol. 3, no. 2, p. 203), you properly note that Charles Warren was a historian, while Samuel Warren was Brandeis' law partner and co-author of the right to privacy article. Unfortunately, you observe that "it was Samuel who was described as 'competent' in Erie." Actually, the competent one was Charles Warren, whose research on Section 34 of the Judiciary Act of 1789 ("New Light on the History of the Federal Judiciary Act of 1789," 37 Harvard Law Review 49 (1923)) Justice Brandeis relied upon in overruling Swift v. Tyson in the Erie case.

Again, my apologies. I thought you'd want to know.
